 - ExcluLouvre Door – Instructions for Safety, Handling, Storage, Installation & Maintenance (revision 2, dated 31 March 2015).
 - ExcluLouvre – Instructions for Safety, Handling, Storage, Installation & Maintenance (revision 2, dated 31 March 2015).
- The walling system can only be constructed as a straight walling system.
- The minimum height of the walling system incorporating doorsets is equal to the minimum height of the compatible doorset listed.
- The minimum width of the walling system incorporating single leaf doorsets is 0.745 m. The minimum width of the walling system incorporating double leaf doorsets is 1.045 m.
- The approval certificates referred to are 234d Part 2 (Issue 04), 234d Part 3 (Issue 05), 234f (Issue 05) and 234g (Issue 02).
- When the fixed louvre panel is used above a doorset (i.e. as an overpanel) the maximum height of the fixed louvre panel is 5.0 m minus the height of the doorset.
- This dimension can only be achieved when certain compatible locking systems are used. Refer to the notes within the relevant certificate/ Red Book entries for details of the restrictions.
- This doorset is only compatible with the relevant ExcluWall Walling System when the doorset is fitted with a compatible internally key-driven locking system. Refer to the appropriate LPCB certificate listed for full details of the doorset.
